POLICIES & PROCEDURES

- Access the building during normal business hours only.
- All guest must sign a waiver.
- Guests thirteen (13) years old and below must be accompanied by a parent or guardian eighteen (18) years or older.
- Outside food, alcohol, and glass containers are not allowed in the facility.
- Appropriate non-marking athletic shoes are required on all wood floors within the facility.
- Proper attire must be worn at all times. This is not a shirtless facility.
- Non-alcoholic drinks in re-sealable plastic containers are permitted.
- Use all equipment properly.
- Bikes, skateboards, roller skates/blades, or shoes with wheels are strictly prohibited.
- Under Title III of the Federal Americans with Disabilities Act (ADA) and virtually all state laws, service animals who are trained to perform work or tasks for the benefit of a person with a disability and properly identifiable as a service animal are allowed in Open Court Sports Complex. By the same state law, the ADA provides no protection for emotional support animals in public accommodations and are not allowed in the facility.
- Smoking, tobacco, and vaping products are not allowed in the facility.
- Open Court Sports Complex will not be responsible for lost, damaged, destroyed, or stolen personal items. Single day use lockers are provided for a fee.
- If it isn't yours, don't take it. Please respect others' property.
- Open gym on designated date/times. See our website for details.
- Whenever a fire alarm is sounded, please evacuate the building in a calm and orderly manner.
- If you have the flu, a cold, or any other contagious illness, do not enter the facility.
- Any guest who incurs an injury or becomes dizzy/ill, etc. while visiting OCSC should contact a staff person/first responder immediately.
- All guests must follow proper parking rules. Towing is authorized.
- Re-rack and wipe down all fitness equipment after each use.
- Zero tolerance for inappropriate language, acts of aggression, bullying, or discrimination.
- Individuals who engage in unacceptable behavior will be required to leave the facility.
- Open Court Sports Complex reserves the right to revoke or suspend memberships without refund or deny entry as a result of irresponsible, racist, abusive, volatile, or other dangerous behavior.

PICK-UP GAME RULES

- All players will sign up on the list for Open Court pick-up game on a first come, first served basis.
- Games are played 5-on-5 full court. First five (5) players on the list, followed by the next five (5) players on the list.
- You can only sign up yourself when dressed and ready to play – no holding spots.
- All games will be played to 15 points or 15-minutes, whichever comes first.
- Games WILL NOT be played past 15 points. NO WIN BY TWO.
- Each basket counts as one (1) point inside the three (3) point line. Baskets outside the three (3) point line will count as two (2) points.
- Winners shall remain on the court up to two consecutive wins. After the two (2) wins, each player must sign up again to continue to participate.
- If a game starts with no other person(s) waiting to play, there is no need for the 15-minute rule. Another person arriving during the course of the game will constitute the clock to start running.
- All officiating is done by the players on the court.
- Zero tolerance for inappropriate language, acts of aggression, bullying, or discrimination; NO ARGUMENTS or FIGHTING over calls.
- Prolonged arguments will result game clock stopping and all ten players being removed from the floor. The next ten (10) players on the list will then start their twelve (12) minute game.
- All reasonable and/or sensible calls shall be honored.
- If a call is reasonably contested, the person challenging the call shall shoot from the top of the key to resolve the dispute.
- There is no clock court violation. Note: if a player delays the game (ex: holds onto a player or ball, rolls the ball down the court, etc.) that will constitute a game forfeiture.
- Regarding foul calls, if the defensive player or offensive player calls a foul in the act of shooting and the offensive player makes the shot, the point will count.
- The clock will stop for a severely injured player only.
- If a team loses a player during the game, the next player on the sign-up list, will move into that player's slot. If that team happens to lose the game, the replacement player will remain and be the first player of the challenging five (5) for the next game. The player will not lose their place to play a complete game because of a substitution for a player.
- If a player on the winning team leaves prior to the start of the next game, the challenging team will continue to be comprised of the first five (5) players on the list. The sixth (6th) player on the list shall join the winning team. If the winning team loses players, then next players on the list shall join the winning team.
- Dunking is allowed, however excessive hanging on the rim is not.
- The last pick-up game will begin one hour before facility closing time.
- Proper attire must be worn; i.e., no "shirts and skins" games.
- Pick-up games are designated for thirteen (13) years old and older. Each player must respect the "Responsibility Code."
